### Updated Approved Person/Approved Institution Terms and Conditions

This circular updates Approved Persons ("AP")/ Approved Institutions ("AI") about the key revisions to AP/AI Terms and Conditions ("AP/AI T&Cs"), in accordance with the amended Child Development Co-Savings Act and the Child Development Co-Savings Regulations.

2 The key revisions, which have been updated on 1 Dec 2024, to the AP/AI T&Cs are summarised below:

- Revised paragraphs 1.1 and 6.2 to extend the usage of the Child Development Account (CDA) monies for childminding services under the Childminding Pilot for Infants (Please see <u>MSF press release</u> on this).
- Revised paragraphs 7 and 9 to enhance regulatory powers to stop CDA withdrawals being made at AIs while investigations are ongoing and auto revocation of AP approvals.

3 We have summarised the key changes in the infographics found in the Annex. You may scan the QR code within the Annex to access the latest AP/AI T&Cs. In accordance with paragraph 15.2 of the AP/AI T&Cs, every AP is bound by any amendment which may be made to the AP/AI T&Cs from time to time.

4 MSF values your partnership and looks forward to your compliance of the terms and conditions as AP/AI. MSF will continue to perform routine checks on CDA transactions and will not hesitate to take actions against an AP/AI, including suspending or revoking the approval granted to the AP, if there is any potential breach of the CDCA, CDCR and AP/AI T&Cs.

View the AP/AI <u>Terms and</u> Conditions

For Early Intervention Centres, MSF only registers centres with programmes for children up to 6 years old. Hence, CDA moneys may only be used to pay for such programmes for children up to 6 years old.

# **ENHANCED REGULATORY POWERS**

## clause **7.1D**

### AIS UNDERGOING INVESTIGATION ARE NOT ALLOWED TO MAKE CDA WITHDRAWALS

Under regulation 12(1) of the Regulations, **no AP shall cause or make withdrawals** from a CDA at AIs:

- i. During any period of investigation to determine if there are any grounds to suspend or revoke the approval of that AP.
- ii. On or after the date when the Minister provides written notice of intent to either:
  - Suspend the approval of that AP
  - Revoke the appointment or approval of that AP

## clause **9.1C**

### AUTOMATIC REVOCATION OF AP APPROVALS IN SPECIFIC CIRCUMSTANCES

An approval granted to any AP is revoked on the date on any of the following dates applicable to an AI for which the person was approved:

Als **shall not** make any CDA withdrawals once AP approval is revoked.
